⋒ COUNTY EXECUTIVE 4-YEAR TERM

- Provides leadership and direction for all Allegheny County government.
- Ensures that policy is effective and economical



COUNTY COUNCIL 4-YEAR TERM,

- Approves and amends legislation by the County Executive or a Council member
- Annually adopts a balanced County Budget
- Permits use of County land and levies taxes
- Confirms or rejects agency appointments
- OUR NEIGHBORHOODS ARE COVERED BY DISTRICT 13



CITY CONTROLLER **4-YEAR TERM**

- Collects all City revenue
- Audits all City revenues and expenditures
- Protects City tax dollars from waste, fraud and abuse



COUNTY CONTROLLER 4-YEAR TERM

- · Oversees accounting, audit, management and administrative staff.
- Monitors County fiscal business
- Prepares and certifies
- the state of county indebtedness
- Approves payroll, provides financial reports and disburses funds



COUNTY TREASURER

· Receives, invests, disburses and safeguards the monies of the county



JUDGES: 10-YEAR TERM MAGISTRATES: 6-YEAR TERM

- Resolve disputes between parties and protect the rights of citizens
- See the PA Unified Judicial System and Pennsylvanians for Modern Courts APPELLATE COURTS:
- 1 Supreme Court
- 2 Superior Court
- 1 Commonwealth Court
- 1 Court of Common Pleas
- 20 Magisterial District Judges



DISTRICT ATTORNEY 4-YEAR TERM

- Provides prosecution of crimes in Allegheny County.
- · Accepts referrals from more than 100 active police departments including City of Pgh Bureau of Police, Allegheny County Police Dept, and Allegheny County Sheriff's Dept





- Makes the laws which govern the City of Pittsburgh
- · Regulates revenues and expenses, incurs debt, approves budgets

SCHOOL BOARD 4-YEAR TERM



- Policy-making body of the school district
- · Adopts and monitors budgest and audits
- Establishes criteria, approves curriculum and personnel
- Adopts policies for Student Services

DEADLINE TO REGISTER TO VOTE

The deadline to register to vote is 15 days before an election. This also applies if you are changing your name, party affiliation or address. Applications must be received by 5 pm at the Elections Division:

4 WAYS TO VOTE

There are 4 convenient ways to register to vote or update your registration.

You must register to vote at the address where you actually live – your residence address. Owning property or a business in a county does not make you a resident of that county.

To register to vote:

- Fill out a voter registration application form.
- Your county voter registration office reviews the form.
- If your registration is accepted, you
 will get a voter registration card in
 the mail. The voter registration card
 will show your name, address, party
 affiliation, and the address where
 you will vote.

You have 4 ways to register to vote. You can register:

- 1 ONLINE
- 2 BY MAIL
- 3 IN PERSON
- 4 AT PENNDOT OR
 OTHER GOVERNMENT
 AGENCIES

REGISTERING TO VOTE

To register to vote in Pennsylvania, you must:

- Be a citizen of the United States for at least one month before the next primary, special, municipal, or general election.
- Be a resident of Pennsylvania and the election district in which you want to register and vote for at least 30 days before the next primary, special, municipal, or general election.
- Be at least 18 years of age on or before the day of the next primary, special, municipal, or general election.

When voting at a polling place for the first time, you must show proof of identification, either with photo or not. Learn more about the types of ID you can show.

Approved forms of photo identification include:

- Pennsylvania driver's license or PennDOT ID card
- ID issued by any Commonwealth agency
- ID issued by the U.S. Government
- U.S. passport
- U.S. Armed Forces ID
- Student ID
- Employee ID

If you do not have a photo ID, you can use a non-photo identification that includes your name and address:

- Confirmation issued by the County Voter Registration Office
- Non-photo ID issued by the Commonwealth
- Non-photo ID issued by the U.S. Government
- Firearm permit
- Current utility bill
- Current bank statement
- Current paycheck
- Government check

In Pennsylvania, you have two options for mail ballots.

- Mail-in ballot Any qualified voter may apply for a mail-in ballot. You may simply request this ballot without a reason.
- Absentee ballot If you plan to be out of the municipality on election day or if
 you have a disability or illness that prevents you from going to your polling
 place on election day, you can request this ballot type, which still requires
 you to list a reason for your ballot.

In order to request either ballot type, you must be registered to vote. Check Your Registration Status to review your registration information.
